(3) That any apprentice(s) employed in the above period are duly registered in a bona fide apprenticeship program registered with a State Apprenticeship agency recognized by the Bureau of Apprenticeship & Trng., U.S. Dept. of Labor, or properly enrolled in a bona fide training program approved for application on public works construction projects by the appropriate state (SAC) and/or federal agency(ies) (BAT) if and as required by law & applicable federal regulation.
